By covering the academic unit 'In-house internship' satisfactorily, students develop capacities that belong to competency level 1 in order to be able to deal with 'real clients'. In this academic unit students' clinical reasoning is directly linked to the execution of relevant physiotherapeutic skills on specific patients, and dealing with clients is considered as more than a merely technical skill.
